 - Approved list of trainees with Voter Id Cards/Ration Cards/Aadhaar Cards.
 - Bank Pass Book duly updated.
 - · G.B. Resolution Book.
- After receipt of 3rdinstalment of fund from WBWDU, audited Utilisation Certificate and Statement of Accounts will have to be submitted and completion certificate in respect of the sanctioned project has to be obtained from WBWDU.
